The Sub-Fund will invest its assets primarily in units of UCITS and/or other UCIs as described in article 41 (1) indent (e) of the 2010 Law, including Exchange Traded Funds (ETFs) whose applicable investment rules are equivalent to the investment rules applicable to the Fund in accordance with the applicable laws, regulations and approaches adopted by the CSSF, which mainly invest a) in equity securities and derivatives thereof, b) in transferable debt securities and derivatives thereof, c) indirectly in commodities through eligible instruments, in particular via eligible UCITS and ETFs, and derivatives thereof and d) in bank deposits and money market instruments, with a broad and unrestricted geographical area.

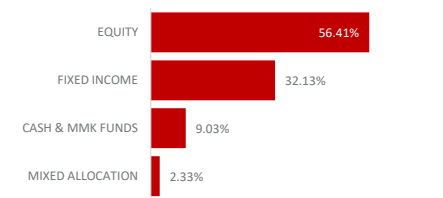

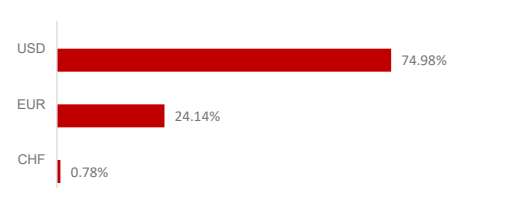
Performance



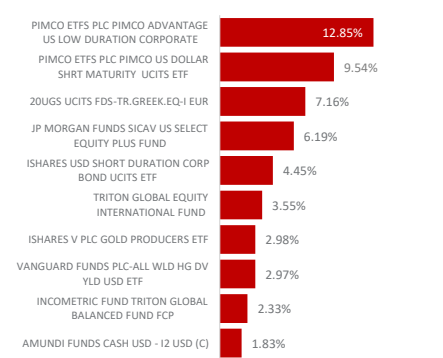
Asset Exposure



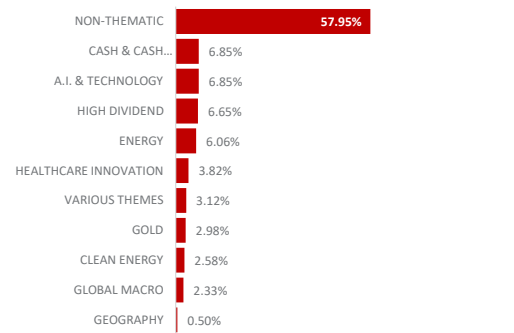
Currency Exposure

Q2 Commentary

The US-Iran war which erupted in late February was the defining macro event of Q2 2026, driving Brent crude to nearly \$99/bbl and stoking inflation fears that sent the 30-year Treasury yield to 5.20% in mid-May, its highest since 2007. The Strait of Hormuz blockade kept energy markets on edge for much of the quarter, with each diplomatic development triggering sharp cross-asset moves. A fragile ceasefire and subsequent US-Iran MOU in mid-June reversed the oil spike. Brent fell to ~\$71/bbl by quarter-end, relieving pressure on bonds and unlocking a broad equity rally. Beyond oil, yields faced additional upward pressure from rising US real yields, swelling fiscal deficits, and Japan's super-long bond surge driven by PM Takaichi's expansive spending plans. On monetary policy, Kevin Warsh succeeded Powell as Fed Chair in late May, and his first FOMC meeting left rates unchanged at 3.50–3.75%, though markets briefly priced in hike risk for 2026. Despite the volatility, the S&P 500 posted its best quarter since 2020, adding over \$8 trillion in market value, led by a +20% surge in Magnificent Seven stocks and record gains in semiconductors. The AI investment theme remained the primary equity driver, with MSCI EM also posting its best quarter since 2009 on the back of Asian chip demand. Against this backdrop, the Triton (LF) Flexible Multi-Asset FOF (Class A) recorded a return of +1.95%.
