Investment Aim

The Fund invests for long-term returns in the shares of companies that are positioned to benefit from efforts to adapt to climate change. Such companies should be aiming to be market leaders in their fields. The Fund can invest in companies that are listed in any country, both developed and developing. There aren't restrictions on the market values (also known as market capitalisation) of the companies held in the Fund. The Fund may also invest in financial derivative instruments. These are financial instruments whose value is based on underlying assets, for example bonds, stocks, currencies. The derivatives the Fund can use include currency derivatives and futures, among others. The Fund uses derivatives to protect against financial risks (hedging) and to manage cash flows. Financial derivative instruments may also be embedded in other instruments used by the Fund.


